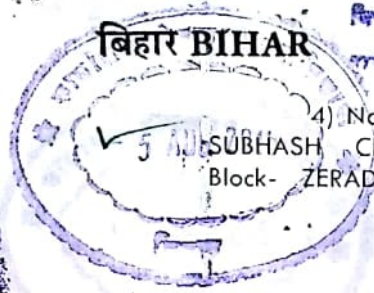
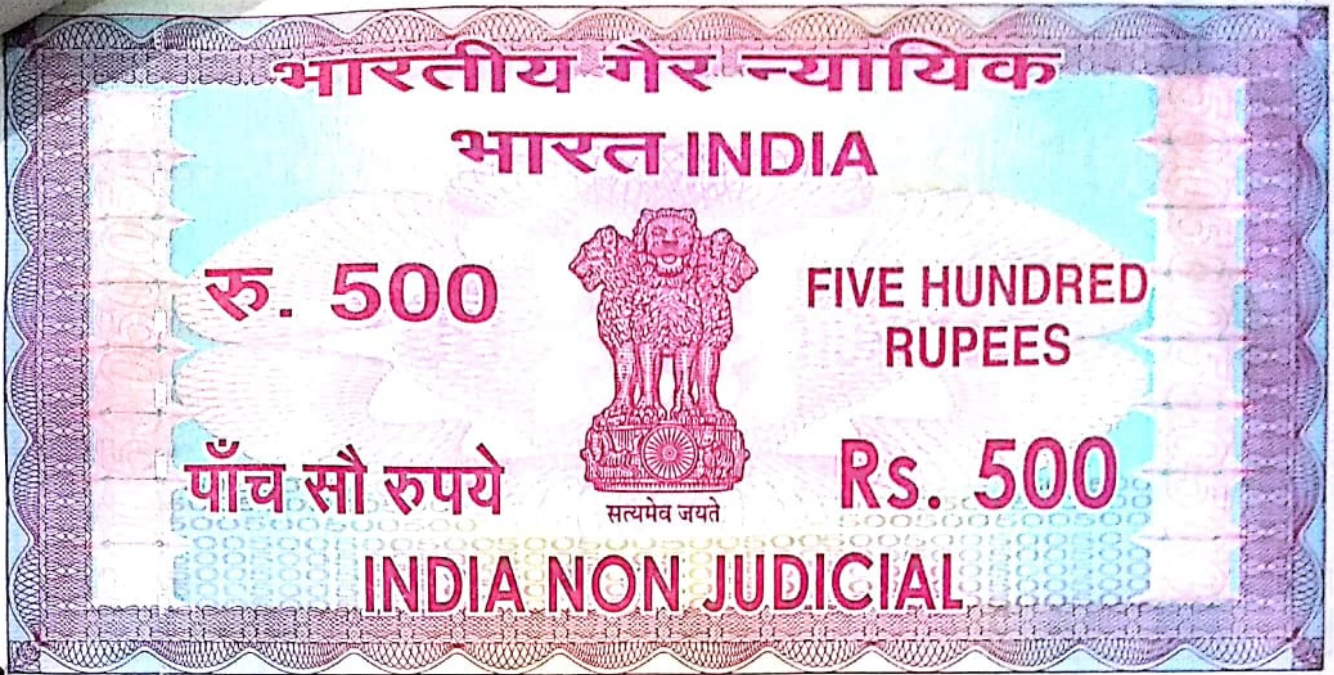

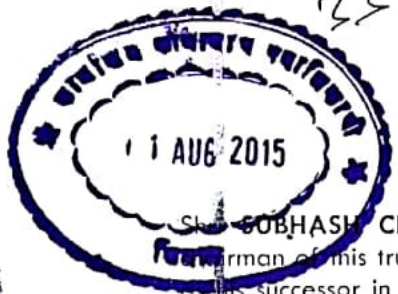

श्री SUBHASH CHAND PRASAD allies SUBHASH who will hold office of the Chairman of this trust for life. During his lifetime he may nominate one of the trustee as his successor in office. The Trustee so nominated shall enter into the office of the chairman after the lifetime of the present chairman Shri SUBHASH CHAND PRASAD allies SUBHASH. If the present Chairman fails to nominate his successor during his life time in that event after his life time the remaining trustee shall elect one amongst themselves as the chairman of the board of trustee and without prejudice to the generality of the objects and power above mentioned, they shall have to do all or of the following

- i) To enter into contracts and borrow money from Banks, Institution or individual for the purpose of the trust and management of its properties and assets.
- ii) To appoint consultants for specific purpose on such terms and condition as they may deem fit.
- iii) To enter into agreements with organizations and individual for execution of any projects that may be undertaken or taken over by the Trust from time to time.
- iv) To make rules and regulation from time to time for the management and conduct of the affairs of the Trust and its properties and assets.
- v) The number of Trustees shall be not being less than more than nine. The trustees shall be trustee for their life time but any trustee may resign by giving notice in

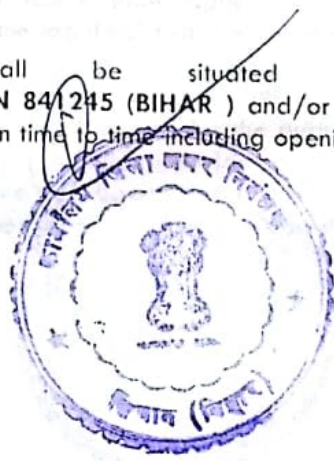

NOW THIS DEED OF TRUST WITNESSETH as follow:

1. In pursuance of the premises above the Settlor does hereby settle upon and convey unto the Trustees the sum of Rs. 500000 (Five Thousand One Only.) to hold the same in Trust with the powers and subject to the provisions hereinafter contained concerning the same.
2. The name of the Trust shall be **RAJBANSHI LOK KALYAN TRUST : JAMA PUR ZERADEI SIWAN (BIHAR)**
3. The Office of the Trust shall be situated at **AT-JAMAPUR P.O ZERADEI DIST-SIWAN PIN 841245 (BIHAR)** and/or at such other places as the Trustees may decide from time to time including opening branches of the trust at the place in India.

4. All the members/trustee at any time must have sound character and have social identity and status.

5. The First Trustees shall be:
Mr. SUBHASH CHAND PRASAD allies- SUBHASH

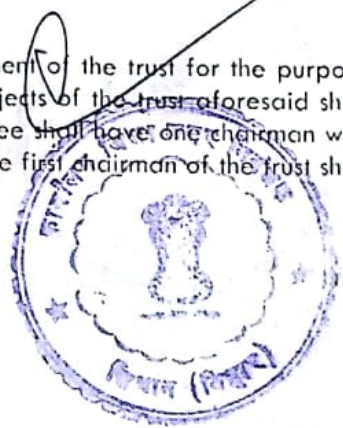
The aforesaid Trustees have signed this Deed also in acceptance of the office assigned to them through this instrument

6. The above-named First Trustees along with other co-opted Trustees shall be Trustees for life. The Trustees can co-opt with mutual consent any other person or persons, as Trustees. The total number of Trustees at any time shall however not more than nine. On the death of any Trustee the remaining Trustees shall appoint a person as a Trustee in place of the deceased from among the legal heirs of the deceased. The minimum number of Trustees shall be Two.

7. Management of the trust: The general Management of the trust for the purpose of managing the affairs and properties out the objects of the trust aforesaid shall be vested in the Board of Trustee. The Board of trustee shall have one chairman who shall be the principal executive officer of the trust. The first chairman of the trust shall be

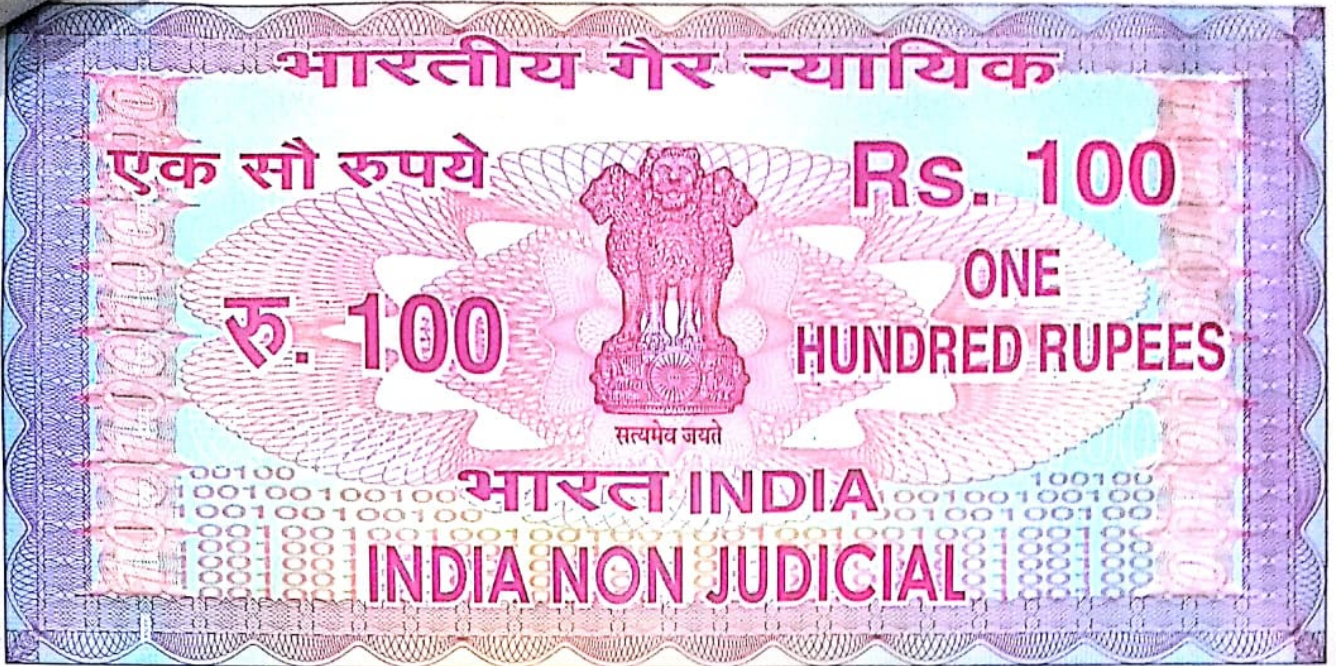
8. MEMBER OF THE TRUST

The settler and the life time trustees may constitute with their mutual consent the board of the trust to manage the day to day affairs under the kind control of the founder.

However, later on, one elected member from the life-time Trustees and two elected from the ordinary Trustees and one from the associates shall be added on to the Board. Without the presence of at least two life-times Board members the meeting of the Board shall not be valid. The quorum of the Board will be four, but at least two of the life-time Board members should be present. The members of the Board shall not be more than nine or less than two. If it is nine, one from the life-time Trustees and one from the ordinary Trustees additionally shall be added on.

MEMBERSHIP RULE-

The present G.B. Trustee if think fit for the benefit of the trust and to manage the affairs of the trust may admit an outsider as ordinary member of the trust with the mutual consent and with the majority of the opinion of the members if the following conditions is satisfy-

1. The members of the trust must be a citizen of INDIA
2. Age should not be less than 21 years.
3. Having sound character and moral and has not been convicted by any court in India
4. Having sound mental and good health.

9 CHAIRMAN AND SECRETARY-

- ✓ Chairman is permanent for life-time as he is he Founder of the Trust for the propagation of his ideals and techniques based on ancient esoteric spiritual wisdom of India, for the welfare of the human beings irrespective of caste, creed and colour.
- ✓ Among the Board of Trustees there must be a permanent Chairman with advisory capacity in all matters of the Trust and shall have the right to deal with the mystic side of the spiritual realm of the member and well-wishers of the Raja Yoga. His period must be life-time. And he has to manage the organization and propagation of the Trust. He shall have the right to

11. The Trust moneys shall not be invested with any private individuals or firm or association of persons or body of individuals.

12. The secretary/GOB shall maintain all account of the Trust regularly. The accounts shall be audited by a Chartered Accountant, every year. Accounts will be closed on 31st March, each year.

13. No amendments to this Trust Deed and Bye-laws shall be made which may prove to be repugnant to the provisions of Sections 2 (15), 11, 12, 13 and 80-G of the Income-tax Act, 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income-tax.

14. In case of death, inability, resignation or refusal on the part of any Trustees to Act, as such Trustee the remaining Trustees shall be entitled to nominate any other person as they

may think fit and proper to act as Trustee in place of the Trustee so dying, refusing to act or being unable to act:

Provided that the Trustee so appointed will have the same onus and right as if he was originally appointed the Trustee under these presents.

15. The Board of Trustees may remove from office any Trustee except the Chairman and Secretary if in their opinion such Trustee has ceased to represent the interest which he purports to represent on the Board, provided that reasonable opportunity is given to such Trustee to make any representation against the proposed action.

16. In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amount the Trustees, but the same shall be transferred to another charitable Trust/society whose object are similar to those of this Trust and which enjoys recognition under Section 80-G of the Income-tax Act, 1961, as amended from time to time.

17. The Trustees can received gifts/donations either from any one of them or from others in cash or in kind and the gift so received together with the initial sum of Rs 5000.00 (Rupees Five thousand one only) from founder settled under this Deed shall form the corpus of the Trust.

18. The funds and properties of the Trust shall consist of:

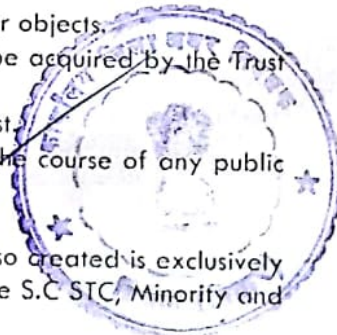
- ✓ The sum of Rs 5000.00 (Five Thousand One Only) which has been settled by the settler.
- ✓ ✓ Gifts/donations either in cash or in kind which may be made by any

donations made for any such specified purpose or objects.

- ✓ Properties movable and immovable which may be acquired by the Trust by purchase, exchange, lease, gift or otherwise.
- ✓ Income and profits from the properties of the Trust.
- ✓ Any fees, charges, etc, as may be collected, in the course of any public or private performance by artistes, etc.

19. The objects of the Trust: The main object of the trust so created is exclusively for the welfare and educational aid of general mass like S.C STC, Minority and others weaker section of the society are as below :-

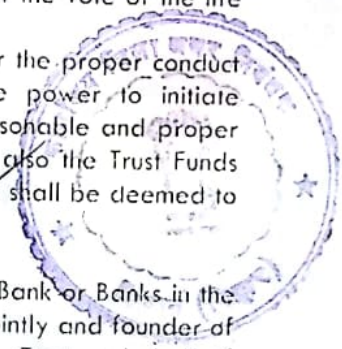
- ✓ To provide fees, books, equipments, free ships, and/or scholarships to deserving students.
- ✓ To feed poor students and to start free student homes and free hostels.
- ✓ To help and assist poor and deserving people in marriage.



- ✓ To conduct seminars/workshops and arrange special tuition/training for students.
- ✓ To provide/assist in setting up village industries and other S.S.I
- ✓ To make donations to other public charitable Trusts/institutions recognized under Section 80-G of the Income-Tax Act, 1961.
- ✓ To set up and operate schools residential or day school, colleges ,language college ,training centre, Technical training Centre, Industrial Training Institute (I.T.I.), Engineering college, polytechnic college ,medical college and all other educational faculty necessary for the upliftment of the life style of the society and to make the society well educated.
- ✓ To conduct nutritional and health services and to establish Hospital & Medical college to provide medical aid and education to the poorer and weaker section of the society.
- ✓ To conduct/operate programmes for providing nutritional assistance e.g. to operate a school/lunch/food programmed for children, operate nutritional supplement programmed for needy women which shall be provided/conducted/distributed free of charge.
- ✓ Testing of diets from nutritional view point.
- ✓ To render assistance to poor patients by providing medicines etc., provisions of health care, preventive medical services (including dental services)
- ✓ Assistance to hospitals in setting up the various facilities such as Blood Bank, Eye Bank, Burn Centers, etc. for the poor patients.
- ✓ Provision of outdoor dispensary or assistance thereof and also to run "Mobile" medical service.
- ✓ Conduct education in health care or provide assistance in the provision of primary health care education.
- ✓ To set up hospitals/nursing homes for children/women.
- ✓ To render assistance to the handicapped.
- ✓ To provide monetary assistance and social services in case of natural calamities.
- ✓ To render financial assistance to the poor and the disadvantaged.
- ✓ To promote advancement welfare of the people.
- ✓ To set up Vocational Training for women/widow /Divorce women etc. To promote social arts, culture, sports and others activities.
- To make awareness in the society about aids, polio, illiteracy, poverty, and others necessary activities from time to time.
- And all other activity (Education & Health) for the welfare of the society from time to time with the consent of the majority of the vote of the life time trustee.

20 . The Trustees shall have all powers as may be required for the proper conduct of the affairs of the Trust. The Trustees shall have the power to initiate prosecutions and defend legal proceedings as may be reasonable and proper for safeguarding the assets and properties of the Trust as also the Trust Funds and interest. Any action taken by such Trustees in this regard shall be deemed to have been taken and ratified by all Trustees.

21. The Trustees may open an account or accounts with any Bank or Banks in the name of the Trust to be operated upon by any one Trustee jointly and founder of the trust or severally or the authorized representative of the Trust on behalf of the Trust.

The surplus funds of the Trust which has not been spent in any year shall be invested in the modes prescribed under relevant sections of the Income-tax Act, 1961, as amended from time to time.

23. The Trustees shall at their discretion, acquire, purchase or sell immovable properties or movable properties in the course of managing of Trust. However, any sale of immovable shall require prior consent of at least 3/4th majority of the Trustees.

24. No income of the Trust shall be applied for the personal benefit either of the Trustees or of the Settler except the genuine day to day expenses necessary to discharge the duty and obligation towards the achievement of the object of the trust, that expenses will be reimbursed to the person /trustee concerned.

25. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/ Members of the Governing Body, but the same shall be transferred to another Charitable Trust, Society, Association or Institution whose objects are similar to those of this Trust and which enjoys recognition under relevant section of the Income-tax Act, 1961.

26. No amendment to the terms of this Deed shall be made without obtaining the prior written permission of the Commissioner of Income-tax. However, the amendments of be carried out shall not infringe the provisions of the Income-tax Act, 1961.

27 The objects of the Trust shall be achieved without involving any activity for profit.

28. The Trustees and the members of their family shall not be entitled to the benefits of the Trust.

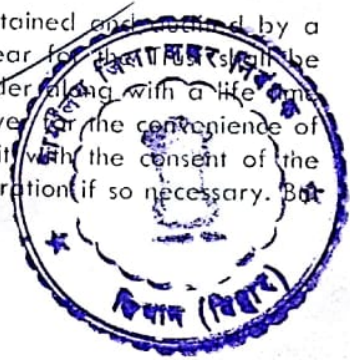
29. The Trust formed is irrevocable.
